Subject: Capacity expansion of Mangalore Hassan Bangalore multi-product pipeline

Sir,

This has reference to PMHBL's letter no. PMHBL/MD/17/2024-25 dated 19.08.2024, requesting PNRB to consider the capacity expansion of Mangalore Hassan Bangalore multi-product pipeline from 2.143 MMTPA to 5.60 MMTPA.

2. In this regard, the Board has approved the request of PMHBL for capacity expansion of Mangalore Hassan Bangalore multiproduct pipeline to 5.60 MMTPA. Accordingly, clause no 3 (b) of Final T&C letter dated 24.11.2011 stands revised as under:

“The capacity of Petronet Mangalore Hassan Bangalore multi product pipeline, length 362.373 kms and 20”/24” inch diameter is equal to **5.60 MMPTA*** as indicated by PMHBL. The Board has decided to declare the Mangalore Hassan Bangalore multi-product pipeline as common carrier with common carrier capacity of **1.12 MMTPA*** to be made available to a third party on open access and non-discriminatory basis.

Note: (* - This capacity is accepted as provisional and the final capacity shall be determined as per the provisions of the Petroleum and Natural Gas Board (Determining capacity of Petroleum, Petroleum Product and Natural Gas Pipeline) Regulation, 2010).

3. The entity shall furnish a performance bank guarantee of the amount as specified in Regulation 8(1) of the Petroleum and Natural Gas Regulatory Board (Authorizing Entities to Lay, Build, Operate or Expand Petroleum and Petroleum Products Pipelines) Regulations, 2010 which states that in case pipeline capacity is expanded for more than fifty percent of its authorized


capacity, the performance bond shall be increased in proportion to the increase and shall be rounded off to the nearest lakh rupees subject to a total ceiling of rupees thirty crores.

4. All other terms and conditions stipulated in T&C letter No. Infra/PL/PP/Exis/17/PMHBL/MBPL/01/11 dated 19.04.2011 shall remain same.

5. Furthermore, PMHBL is advised to obtain prior approval from PNGRB before proceeding with any future capacity expansions or other activities that could affect the final terms and conditions of acceptance issued by PNGRB for Central Government Authorization.
